

# **Investigative Report Concerning Incidents During The 2014-2015 Armageddon Offseason**

## **Gamblers Investigation Summary**

On the evening of March 17, 2015, Atlantic City Gamblers General Manager, Tim K, attended a St. Patrick's Day party at a local acquaintances place of residence in Flemington, New Jersey. Our research has indicated that the party was attended by well over fifty males and approximately one female. At 2:00 am, Eastern Standard Time, Mr. K and thirteen other males left the residence and drove to a local hotel, the Pitchers and Catchers Inn, which is located a few miles up the road.

Mr. K's group was seen entering the hotel property at approximately 2:08 am EST by surveillance footage. An interview conducted with one eyewitness, Mr. [Name Redacted] confirmed this finding as the limping man recalled "Seeing a horde of drunken men, eh" entering the building. Mr. [Name Redacted] also provided us with additional details involving a conversation that he overheard that implied to him "That one male in the group was knowingly underaged." Additional interviews conducted with various staff of the hotel all generally confirmed seeing "a large party of males" check in during the early morning hours of the eighteenth.

Mr. K and associates checked into room thirty-seven and entered at approximately 2:17 am EST. Multiple witness accounts confirmed hearing "grotesque sounds" and "ungodly noises" coming from the room for approximately the next three hours. Mr. [Name Redacted] provided us with additional dialogue on the situation, stating that he clearly heard a man cry out from the room across the hall "Hakuna Matata, my asshole is ready!" Mr. [Name Redacted] also informed us that he's recovering well from his automobile accident. We're not sure why that has any relevance to this report, but we'll leave that up to you.

At approximately 5:23 am EST, Mr. K and associates left the hotel. This was further corroborated by both security footage and interviews conducted with hotel staff. Pitchers and Catchers Inn management provided us with graphic details of the state of the room and items found remaining from its previous occupants, Mr. K's group. Along with the reported photograph that was leaked by Chatbox Sports Network, multiple Miller Lite branded dildos, lubricants, and other various sex toys were scattered among the room. A number of costumes were found lying in the bathroom shower, most of which originated from various Disney movies such as "The Lion King" according to hotel management. Multiple furniture items including a very expensive couch were additionally reported

to us by management as “violently damaged” further adding to the disturbing scene.

On May 31, the Atlantic City Gamblers General Manager addressed the allegations reported by CSN. Mr. K issues the following statement that was released to the public:

"Why they gotta pick on me, lock me up and throw away the key? I ain't a regular G I ain't a regular failure I ain't straight out of Compton, I'm straight out of Flemington. Also whose kid was that, lookin at you Holcombe. Keep Orville out of this."

Within the hour team officials denied the accuracy of this statement blaming a PR mishap. However, despite Mr. K's best attempts our research indicates that he is the only one with access to the Gamblers PR account currently despite security concerns in past years. As for Mr. K's claims of “Orville Holcombe” our research concluded that Mr. H spent St. Patrick's Day at the MacLaren's Pub in Manhattan. This was further verified to us by an employee at MacLaren's Pub, a waitress who goes by the name of Wendy.

In our view, it is believed that Mr. K thought he had sexual relations with the Orville Holcombe of the ECRF Winston Cup Series. However after confirming this to be physically not possible based on time and location, we decided to thoroughly examine the security footage from the night of the incident. Upon completion, our findings discovered that one of Mr. K's associates that night bore a striking resemblance to the famed auto racing star. Further research revealed that said person was a local resident who is confirmed to have been thirteen years of age at the time of the incident. It is not known how active of a participant he was in this apparent orgy, but footage confirms he did enter the room in which this incident took place and remained there until leaving the property with Mr. K's entourage.

Based upon the findings in our comprehensive investigation, with the evidence presented, we have concluded that it **is more probable than not** that Mr. K, was at least generally aware that he was potentially engaging in sexual relations with a minor during his actions in the early morning hours of March 18.

During the second intermission break at approximately 9:17 pm, Eastern Standard Time, the Butterchurners organization took a moment to honor the Veterans and Active Service Members in attendance. These brave men and women were asked to stand by the arena's announcer so that they could be recognized for their sacrifices in front of a sold out crowd.

At this time witnesses claim to have seen the General Manager of the famed AFFL Champion Tennessee Tuntans rise to his feet and loudly proclaim to have served in World War I. We immediately launched an investigation into this claim after being hired by the AFFL. Upon thoroughly researching the records provided to us, we concluded that his age is only that of twenty-five years. Therefore our expert historians have determined that it is highly unlikely that Mr. Samuelsson was a veteran of World War I, despite his statement to the contrary.

We also reviewed numerous footage from cameras and cell phones taken by the various patrons in attendance at the Butterchurners game the night of the alleged incident.
